Developments that occurred to the disclosure	completion of all regulatory procedures regarding the increase of Kuwait International Bank's paid-up capital to K.D 165,376,542.700, as well as the procedures regarding the increase of the Bank's capital share, the matter which will allow trading on the aforementioned Capital Increase shares. We would like also to indicate that the subscription has been closed on 13 June 2023. All of the capital increase shares have been subscribed with the number of 428,571,429 shares for a total amount of KD 60,000,000.060, including the nominal value of KD 42,857,142.900, and issuance premium for an amount of KD17,142,857.160.
