

## Kuwait International Bank K.S.C.P. and Its Subsidiaries

### Financial Leverage Ratio

For the period ended 31 March 2021

The Group's financial leverage ratio comprises of Tier (1) capital (As defined in the instructions on capital of Islamic banks Standard) divided by total exposures which consists of:

1. On-balance sheet exposures
2. Exposures of hedging contracts compliant with Islamic Sharia'a Standards.
3. off-balance sheet exposures

At 31 March 2021, the financial leverage ratio is 10.72% (31 March 2020: 11.63%) compared to the ratio required by regulatory authorities of 3%, Tier (1) Capital of KD 356,456 thousand (31 March 2020: KD 358,733 thousand) and total exposures is KD 3,325,268 thousand (31 March 2020: KD 3,084,371 thousand).
